Fort Lauderdale, Fla. – Caterpillar Financial Services has announced that in 2016, Bergeron Land Development was the third largest purchaser of CAT machines in dollars spent for the Atlanta District of Caterpillar, which includes the states of Florida, Georgia, Alabama, South Carolina and parts of North Carolina.
